## EMERGENCY PROCEDURES

24 HOUR EMERGENCY ADVICE: 0800 764 766

IF THIS HAPPENS	DO THIS
<b>Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or Leak</b>	In the event of a major spill, prevent spillage from entering drains or watercourses. Evacuate the spill area and deny entry to unnecessary and unprotected personnel. Wear full protective clothing including face mask, face shield and gauntlets. All skin areas should be covered. Stop leak if safe to do so and contain spill. Absorb onto sand, vermiculite or other suitable absorbable material. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Dispose of only in accordance with all regulations.
<b>Fire</b>	<b>Call the Fire Service: Dial 111.</b> Not combustible. Use extinguishing media suited to burning materials. Exposure to smoke may be a hazard to health. Prevent fire water from entering drains.

## FIRST AID

<b>If Swallowed</b>	DO NOT induce vomiting. <b>For advice, contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.</b>
<b>If in Eyes</b>	If splashed in the eyes, wash out immediately with running water for at least 15 minutes.
<b>If on Skin</b>	If skin or hair contact occurs, remove contaminated clothing and flush the affected area with running water.
<b>If Inhaled</b>	Remove patient to fresh air. If not breathing give artificial respiration, preferably mouth-to-nose. Seek medical attention if symptoms develop.

## STORAGE &amp; SEGREGATION

**Storage:** Keep out of reach of children. Keep in original containers and tightly closed. Keep away from food, drink and animal feeding stuffs. Store below 25°C in a cool, dry, well ventilated area and protect from sunlight.

**Aggregate Storage Volume Thresholds:** When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current NZS8409 Management of Agrichemicals and the HSNO Regulations.
